



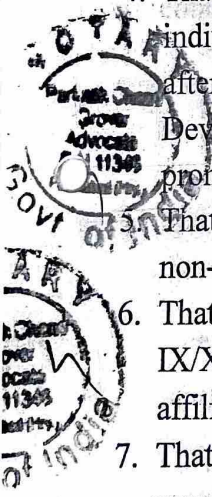

### AFFIDAVIT


Monica Khanna W/o Sh. Anil Khanna Principal of the DAV Public School, Ratia do hereby solemnly affirm and sincerely state as follows:


1. The DAV College Trust and Management society is a registered society under the ACT XXI of 1860.

7. The school undertakes to abide by the provisions contained in affiliation & examination byelaws, directions issued from time to time and the law of the land.
8. That the school will ensure compliance of all statutory requirements like EPF,ESI and Labour Laws etc. with respect to the school and staff of the school.






